

# **THE GRID CHAMPIONSHIP REGULATIONS**

## **QUALIFICATION FOR THE BOCCO KART FINAL**

### **Title 1: Specific Conditions**

#### **1. Organising Company**

The company THE GRID, a French société par actions simplifiée (SAS) with capital of €1,000, whose registered office is located at 20 bis rue Louis Philippe, 92200 NEUILLY-SUR-SEINE (hereinafter the "Organising Company"), organises a THE GRID championship in collaboration with the BOCCO KART Event of Mr Dorian BOCCOLACCI, running from 18 May 2026 and ending on 6 September 2026 inclusive (hereinafter the "Championship").

#### **2. Participants**

The Championship is open to any natural person who is over 16 (sixteen) years of age on 18 May 2026 (hereinafter the "Participant").

Any person who has contributed to organising the Championship is excluded from participating in the Championship and from benefiting from any prize, whether directly or indirectly.

#### **3. Participation terms**

Duration: from 18 May to 6 September 2026.

Registrations for the Championship remain open until the last qualifying round, i.e. at the latest 6 September 2026.

Participation in the Championship requires the Participant to register online on the website [www.the-grid.racing](http://www.the-grid.racing) and to attend in person at the participating E-MOTION network centres on the scheduled day and time, in order to complete their participation through the associated driving session.

The Participant must complete at least one full lap in order to record a best lap time, so as to be included in the ranking referred to in Article 4 of these regulations.

#### **4. Championship format**

The Championship is open to anyone meeting the conditions set out in Article 2 of the Specific Conditions, subject to the format described in this article.

The Championship will consist of seven (7) individual hotlap rounds, each round taking place over a period of two (2) weeks, with a break during the month of August.

The provisional schedule for the THE GRID Championship is set out below, it being specified that it may be subject to minor changes at the initiative of the Organising Company:

- HOTLAP 1: 18 May 2026 to 31 May 2026;
- HOTLAP 2: 5 June 2026 to 14 June 2026;
- HOTLAP 3: 19 June 2026 to 28 June 2026;
- HOTLAP 4: 3 July 2026 to 12 July 2026;
- HOTLAP 5: 17 July 2026 to 26 July 2026;
- HOTLAP 6: 31 July 2026 to 09 August 2026;
- HOTLAP 7: 28 August 2026 to 6 September 2026.

The final is scheduled for 24 September 2026. The Organising Company undertakes to inform participants, within a reasonable time, of any change affecting the dates of the hotlap sessions.

In addition to the HOTLAP sessions, two qualifying rounds will be organised directly on circuit using our E-MOTION ON TOUR simulators, which will travel to the following events:

- From 24 to 28 June 2026: Spa-Francorchamps Circuit;
- From 1 to 2 August 2026: Magny-Cours Circuit.

These two events will offer participants two further opportunities to qualify for the final scheduled for 24 September 2026.

During each round, drivers ranked from 1st to 25th place will be awarded points based on their timed performance. At the end of each of the 7 rounds, a general ranking will be drawn up by adding together the points obtained in each round. In the event of a tie in the general ranking, the drivers concerned will be separated on the basis of their best time recorded on the circuit, assessed as a percentage relative to the best overall time recorded during the same hotlap session.

The top fifty-six (56) drivers in the general ranking will qualify for the grand final held on 24 September 2026 at the E-MOTION Paris centre, located at 115 rue Réaumur, 75002 Paris.

The summary table of points awarded according to ranking is shown below.

At the final, the 56 drivers will be divided into fourteen (14) teams, each made up of four (4) drivers, according to a predefined allocation based on the individual general ranking.

The top fourteen (14) drivers in the general ranking will each be designated team captain. The other drivers will then be allocated in accordance with the composition table below:

The composition of the teams will be final and may not be subject to any challenge or modification, except by express decision of the Organising Company.

For each round, the car and settings are set in advance by the Organising Company and will be identical for all Participants. As regards the vehicle used, all Championship events will be contested on the simulator reproducing the following vehicle:

- Porsche 992 GT3 R;
- Vehicle from the GT World Challenge category.

The Organising Company reserves the right to change the vehicle used in the event of technical, operational or sporting necessity.

## **5. Conditions of Participation**

### **5.1. Registration terms**

The Participant may register for the THE GRID Championship on the website [www.the-grid.racing](http://www.the-grid.racing) by:

- Creating a THE GRID customer account;
- Subscribing to the registration offer set at an amount of €170 incl. VAT.

This registration entitles the holder to a total of two (2) hours of driving time over the entire Championship season. The driver may freely allocate this driving time over the course of the season, subject to availability and the organisational terms set by the THE GRID Organiser. The two (2) hours of driving time correspond to four (4) sessions of thirty (30) minutes each.

Drivers registered for the Championship under this offer will benefit from the following advantages:

- The option to purchase additional driving hours at the preferential rate of forty euros (€40 incl. VAT) per hour, corresponding to two (2) sessions of thirty (30) minutes, instead of the public rate of ninety-nine euros and eighty cents incl. VAT (€99.80 incl. VAT) for the said two (2) sessions.
- This preferential rate will remain applicable to drivers qualified for the THE GRID final, so as to allow them to continue training until the said final;
- The final participation fee will be provided free of charge in full to drivers who have subscribed to this offer. Conversely, customers who chose the standard offer, comprising one (1) hour of driving time at the rate of €99.80 incl. VAT, will remain liable for the final participation fee, set at eighty euros incl. VAT (€80 incl. VAT), if they qualify.

### **5.2. Conditions for valid participation**

The Participant must use a simulator certified as "GT Ultimate" by LP SIMU.

To this end, all parameters of the "GT Ultimate" simulators and of the THE GRID Championship will be configured identically for each round for all Participants in order to guarantee fairness.

Any unauthorised alteration of the technical parameters of the vehicle or of the simulator applicable to a driving session will be regarded as an attempted fraud and will result in the automatic cancellation of the timed result of the driver concerned. Such an irregularity may be identified either in real time during the session or subsequently, in particular by means of an analysis of telemetry data and any other available technical evidence.

This cancellation will take effect with no possibility of reimbursement of the session concerned, nor any form of compensation.

### **5.3.**

The Participant is informed and accepts that the information entered on the registration form shall serve as proof of identity pending the submission of the relevant supporting documents.

## **6. Determination of winners**

At the end of each round, a general ranking will be drawn up by adding together the points obtained by each driver.

The validated and final results will be available on the website [www.the-grid.racing](http://www.the-grid.racing).

## **7. Presentation of the prizes**

At the end of the THE GRID championship final, the team declared the winner of the race will benefit from direct qualification for the final of the "BOCCO KART" event, organised by Mr

Dorian BOCCOLACCI, scheduled for 24 October 2026 at the RKC karting circuit in Paris, the terms of which are set out via the following link: <https://www.bocco-shop.com/blogs/infos>

## **Title 2 - General Conditions**

### **1. Participation**

#### **1.1.**

Participation in the Championship implies full and unreserved acceptance of these regulations (titles 1 and 2) and any addenda thereto.

#### **1.2.**

Participation in the Championship is strictly personal and nominative. Only one participation and/or registration per household (same surname, first name and address) will be accepted, and a Participant may not under any circumstances play under several names or on behalf of another person. Participants authorise any verification of their identity and other information requested, in strict compliance with Article 9 of the French Code Civil.

#### **1.3.**

Any registration made by a means other than that specified in the Specific Conditions will not be taken into account. Any participation that is, in particular, incomplete, illegible, contains inaccurate contact details, or is sent after the registration deadline set out in the Specific Conditions, will be considered void.

#### **1.4.**

Any false statement (identity, address, etc.) and/or any attempted fraud will result in the immediate voidance of the participation, without prejudice to the Organising Company's right to take legal action against the perpetrator of the offence. The Organising Company may exclude any Participant whose dishonest or fraudulent conduct harms the proper running of the Championship.

#### **1.5.**

Any Participant who breaches the provisions of these regulations by any means whatsoever may not claim any prize that might otherwise have been awarded to them, such prize remaining the property of the Organising Company.

### **2. Delivery of the Prizes**

#### **2.1.**

Each winner will be informed of their prize by the Organising Company by any means of its choosing (email, phone call or postal mail) using the contact details provided when registering for the Championship. Non-winning Participants will not be notified.

The 56 Participants selected for the final will be notified within 5 days of the publication of the final results on the Organising Company's website.

They will then have a period of 5 days from notification to confirm their participation in the final.

If unavailable on the date of the final, or if they fail to confirm their attendance within the above period, the Organising Company will award the place of the Participant concerned to a substitute. The latter will then be notified immediately and must confirm their attendance within 3 days.

## **2.2.**

The prizes awarded may not give rise to any dispute whatsoever on the part of the winner, nor to the delivery of their cash equivalent (in full or in part), nor to their exchange for any reason whatsoever. However, the Organising Company reserves the right to substitute, at any time, any one of the prizes offered with a prize of equivalent value, without its liability being engaged as a result.

## **2.3.**

Only one prize will be awarded per Participant. If the winner does not wish or is unable to take possession of their prize or to use it during the validity period, they will not be entitled to any compensation, and the Organising Company reserves the right to award the prize to a substitute winner.

Prizes not awarded due to an insufficient number of Participants and/or winners will remain the property of the Organising Company, which may, if it wishes, offer them again in a subsequent competition.

## **2.4.**

Prizes are awarded on a nominative basis and may under no circumstances be collected or used by any other person designated by the Participants who won them.

## **3. Use of equipment/connection**

In view of the participation arrangements described in the Specific Conditions, the Organising Company disclaims all liability in the event of misuse, of any incident linked to misuse of the equipment or software by the Participant, of vandalism, disruption, breakdown, hacking or any technical event resulting in a malfunction of the server, Internet access, the internet or telephone connection, or the computer, which could, for a given period, prevent access to the Championship.

In the event of a technical malfunction of a simulator preventing a race or hotlap from being completed, the Participants concerned will be reimbursed up to the price of the competition affected by that malfunction.

In any event, participation in the Championship implies in particular the Participant's knowledge and acceptance of the characteristics and limitations of the Internet, and in particular the lack of protection of certain data against possible misuse or hacking, or the risk of contamination by any viruses present on the network, as well as acceptance of the regulations of the sim centre concerned.

## **4. Personal Data**

### ***4.1. Processing carried out***

The Participant's personal data is processed by the Organising Company on the basis of consent and the management of the Participant's contractual relationship with the Organising Company. The processing of this personal data is carried out in particular in compliance with Law No. 78-17 of 6 January 1978, as in force, and with European Regulation 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter the "Personal Data Legislation").

When participating in the Championship, the Participant will be asked to complete a form on which certain data, marked with an express indication, will be mandatory. Other data is

optional. If the Participant fails to respond, or if the personal information provided is inaccurate, the Organising Company will not be able to take the participation into account. In addition, after the winners have been determined, the Organising Company may collect certain additional information directly from them for the purposes of properly delivering the prize(s) to be won.

The processing of Participants' personal data is intended in particular to raise awareness among the Organising Company's staff on diversity issues, and for the organisation, management and improvement of the Championship and the related promotional operations, the handling of participation, the determination of the winner(s), and the awarding or delivery of the prize(s).

The Organising Company processes, collects and retains only the personal data voluntarily provided by the Participant. In this regard, the Participant guarantees the truthfulness and accuracy of the information provided by them.

#### ***4.2. Recipients of the Data***

Access to Participants' personal data is granted only to the persons and departments authorised to have knowledge of it for the purposes of carrying out and managing the processing purposes mentioned above (e.g. marketing and/or communication departments of the group to which the Organising Company belongs, technical hosting and maintenance service providers, etc.) and/or to the extent that such access is required by a legal or regulatory basis.

The Organising Company ensures that these recipients implement appropriate security and confidentiality measures so that personal data is protected.

#### ***4.3. The Participant's rights***

The Participant has the right to access, rectify, restrict the processing of, erase and request the portability of their personal data by writing to the email address specified in Article 8 of the Specific Conditions. Using the same email address, the Participant may also object, on legitimate grounds, to the Processing of their personal data, including processing for marketing purposes. They also have the right to issue specific or general instructions regarding the retention, erasure and communication of their data after death.

The Participant may also lodge a complaint at the following address: [dpo@e-motion.racing](mailto:dpo@e-motion.racing), or with the French data protection authority, the Commission Nationale de l'Informatique et des Libertés (CNIL), if they consider that their rights are not being respected. For further information, the User is invited to consult the CNIL website at: [www.cnil.fr](http://www.cnil.fr).

#### ***4.4. Data retention period***

The Organising Company undertakes to retain the Participant's personal data for the duration of the Championship and of the awarding of the prize(s), which may not exceed 3 months, extended, where applicable, by any statutory or regulatory limitation periods to which the Organising Company may be subject.

#### ***4.5. Data Security***

The Organising Company undertakes to maintain adequate technical and organisational security measures in order to guarantee the security and confidentiality of Participants' personal data, in order to protect it from any unauthorised destruction, loss, alteration or disclosure.

### **5. Disputes and liability**

#### **5.1.**

The performance of the Championship and the interpretation of these regulations are governed by French law. Any dispute that cannot be settled amicably will be submitted to the competent French courts.

## **5.2.**

Any claim or complaint by a Participant, for whatever reason, must be sent to the Organising Company within a maximum period of one (1) month after the close of the Championship, by registered letter with acknowledgement of receipt to the Organising Company's Address mentioned in Article 8 of the Specific Conditions. No other method of claim or complaint will be taken into account. This letter must state the precise date of participation in the Championship, the Participant's full contact details and the exact grounds for the claim.

## **5.3.**

The Organising Company reserves the right to shorten, extend, postpone, amend or cancel the Championship or the date on which winners are determined, should circumstances so require, in particular in the event of force majeure, without Participants being entitled to claim any compensation or the Organising Company's liability being engaged as a result.

## **5.4.**

Without its liability being engaged, the Organising Company may cancel or suspend all or part of the Championship if it appears that fraud or irregularities of any kind have occurred during its course, without prejudice to any legal action it reserves the right to take against the persons concerned.

## **5.5.**

The Participant acknowledges and accepts that information derived from the Organising Company's computer systems has evidential value in any dispute relating to the Championship and to the connection data or the computerised processing of such information.

## **5.6.**

The Organising Company may not be held liable for the consequences of any delays or losses of postal or electronic correspondence not attributable to it.

## **5.7.**

The Organising Company disclaims all liability in the event of any incident and/or accident and/or direct or indirect damage or loss that may occur during the period of enjoyment of the prize and/or as a result of its use. The Organising Company may not be held liable for the use or resale of prizes by winners.

## **6. Receipt of notifications and informational newsletter**

The Participant may, at any time and free of charge, ask the Organising Company to stop receiving advertising or prospecting communications by contacting the Organising Company directly at the address given in Article 8 of the Specific Conditions, or by means of the unsubscribe link included in any prospecting communication sent by email. This objection does not affect the lawfulness of messages sent before the objection was made. In accordance with Article L.223-2 of the Consumer Code, the Participant is informed of their right to register free of charge on the telephone cold-calling opt-out list ([www.bloctel.gouv.fr](http://www.bloctel.gouv.fr)).

## **7. Reimbursement of costs incurred to request the regulations**

The request must be sent by ordinary letter to the Organising Company's address given in Article 8 of the Specific Conditions, specifying the name of the Competition concerned.

Reimbursement of postage costs relating to the request for the regulations will be made on the basis of an ordinary letter weighing less than 20 grams, stamped at the standard rate. It may be obtained on simple written request enclosed with the request for the regulations, throughout the duration of the Championship, by sending a bank details statement (RIB) to the Organising Company's address.

Reimbursement of connection costs incurred in participating in this Championship will be made on simple written request to the Organising Company's address, accompanied by a copy of the supporting invoice(s) and the following information: dates, times and duration of connection to the pages concerned. Reimbursement will be made on the basis of a local call at the reduced rate, for a duration not exceeding ten (10) minutes. This reimbursement applies only to Participants who do not have an unlimited internet subscription. The reimbursement request must be sent by ordinary mail to the Organising Company's address, accompanied by the bank details statement (RIB) of the holder of the Internet subscription and proof of the Participant's Internet subscription.

Any reimbursement request that is, in particular, unfounded, incomplete, illegible, contains inaccurate contact details or is insufficiently stamped will not be accepted.

Any reimbursement request received by email will not be taken into account.

Only one reimbursement request per household will be taken into account.

No reimbursement request will be honoured after a period of 15 (fifteen) calendar days from the closing date of the Championship.
